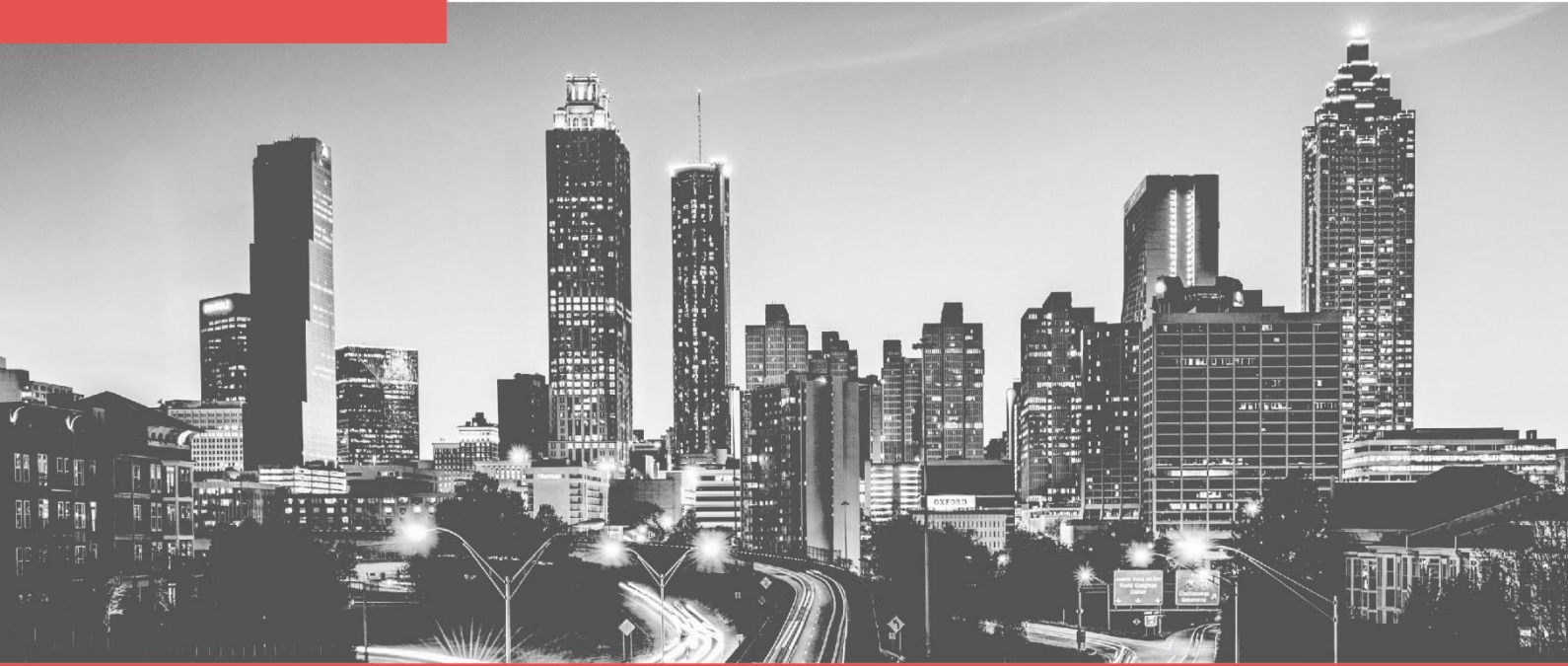

Regulatory Compliance

1.1 Federal Communications Commission (FCC)
